FDNY 911Calls Transcript –EMS- Part 4 9-11-01

RECORDER: The following portion of tape begins at 0912 hours, 01 seconds, taken from position 16, dictaphone prolog originally recorded on cassette 571, DRM 4, deck 2, on September 11th, 2001.

CRO: EMS 8662.

OPERATOR: 8662, I'm 1387. I have a bad location in Manhattan, caller on the line.

CRO: Caller in Manhattan, is the person breathing?

CALLER:

CRO: Okay. Is the person breathing?

CALLER:

CRO: He's alive and he's conscious and awake?

CALLER:

CRO: He's conscious; he's conscious and awake?

CRO: A male?

CRO: Is it regular Thames or West Thames?

CRO: Let me see. West Thames. And what is the cross street between?

CRO: We're going to go to there, where it is.

CALLER:

CRO: South End Avenue. And what is the other one?

CRO: On the corner?

CALLER:

CRO: The Hudson River. Okay. Hold on one second. Hudson River. Okay. And nobody is there with him; right?

CALLER:

CRO: You are not there?

CALLER:

CRO: I know. But he came back here.

CRO: There's a bunch of ambulances there. He should have stayed there. They'd treat him on the scene.

CRO: Oh, my God. Okay. They'll be there soon.
